Licensure In Connecticut

Landscape architecture is a licensed profession in Connecticut. Through education, training and examination, licensed landscape architects are qualified and competent to render professional landscape architectural services in a manner that will protect the public health, safety and welfare. Landscape architects are trained to work on community master plans, site planning, highway design, pedestrian walkways, garden design, wetlands construction and mitigation, park and trail systems, erosion control, historic preservation and stormwater management, to name just a few aspects of the profession.

Under Connecticut's practice act, no unqualified or untrained person may perform the work of a landscape architect, as defined by state law (Chapter 396 of the Connecticut General Statutes). Landscape architecture is regulated by the State Board of Landscape Architects, part of the Occupational and Professional Licensing Division of the State of Connecticut Department of Consumer Protection. The Board is comprised of four professional members and three public members.

Candidates may apply to sit for the Landscape Architect Registration Examination (LARE) with a professional degree in landscape architecture from a college or university accredited by the Landscape Architectural Accreditation Board and evidence of a minimum of two years' practical experience under the direct supervision of a licensed landscape architect. Candidates with these credentials shall apply directly to the Council of Landscape Architectural Registration Boards (CLARB) for admission to the examination.

Licensed landscape architects in the State of Connecticut are required to participate in continuing education programs in order to maintain licensure, as established by Public Act 97-174. Regulations require each licensed landscape architect to obtain 24 continuing education units (CEUs) within each two-year period. One continuing education unit is the equivalent of one contact hour of technical presentation acceptable to the Board of Landscape Architects.
