The Connecticut Chapter of the American Society of Landscape Architects (CTASLA) has announced the winners of its annual **Connecticut Professional Awards** competition, presented at the organization's annual meeting and awards ceremony on December 12.

CTASLA conducts the awards competition to recognize excellence in landscape architectural design, planning and analysis, communication, and research. To be eligible, an applicant must be a landscape architect or designer in the state of Connecticut, and the entrant or project location must be based in Connecticut.
